Board Reviews Presentation on the Goals of the Mountain View Family Center

Priscilla Figueroa, Director of Family Engagement shared a presentation on the goals of the Mountain View Family Center. The presentation included the accomplishments at the Family Center for 2020-2021 which included hosting events in partnership with community providers to meet the needs of MVSD families; serving as an alternate site for student programs; being a resource of information and services for community and families; and providing support as a parent technology resource. Ms. Figueroa highlighted the Family Center goals which include conducting a community needs assessment, providing targeted services based on identified community needs, collaborating with non-profit and community partners to provide resources and services, and identifying and serving underrepresented communities in the District. The presentation concluded with a review of the next steps for the Family Center including continuing to cultivate partnerships with organizations that provide resources to MVSD families; continuing to collect data to determine student and family needs; and providing targeted services based on identified community needs.
