

Board Approves Audit Report Indicating MVSD Once Again Earned an Unmodified Audit Opinion

Gema Ptasinski, Audit Manager for CliftonLarsonAllen, LLP reported the results of the District's annual financial audit. MVSD's tradition of ensuring fiscal accountability continued as the District received another outstanding audit opinion on the yearly state mandated financial audit. Auditors gave MVSD an "unmodified" audit opinion, the highest opinion that can be rendered by an accountant. Ptasinski also reported on the Bond Financial and Performance Audit that was completed and received an "unmodified" opinion, concluding that in all significant respects, MVSD has properly accounted for the expenditures of the funds held in the Measure SS and Measure M Bond Building Funds, and that such expenditures were made on authorized bond projects. The Bond Financial and Performance Audit is not required but the Board of Education and administration requested an annual audit for added transparency for the District's bonds, Measure SS and Measure M.

## Board Approves Resolutions Proclaiming Public School Volunteer Week, Public Schools Month, and School Library Month

Joining the State Department of Education, the Board of Education approved a resolution proclaiming the week of April 18 through April 22, 2022 as Public School Volunteer Week, and urged all citizens to join in this observance in recognizing the dedication and commitment of school volunteers to inspire every student to think, to learn, to achieve, and to care. The Board also approved resolutions proclaiming the month of April as Public Schools Month, recognizing America's public schools for instilling a love of learning in children and teaching them the skills to pursue satisfying, productive lives; and School Library Month, celebrating the essential role school libraries play in providing materials that encourage growth and knowledge, as well as a love of literacy in students.
