## **Board adopts Resolutions in support of Week of the School Administrator, America's Safe Schools Week, Red Ribbon Week and Character Education Month**

The Board joined the State Department of Education by signing resolutions proclaiming October 9-15, 2022 as Week of the School Administrator, October 15-21, 2022 as America's Safe Schools Week, October 23-31, 2022 as Red Ribbon Week, and the month of October, 2022 as Character Education Month.

## **Board Approves Agreement with First LA**

The Board approved the agreement with First 5 LA to provide \$32,500 in grant funds for district-wide and community-wide efforts to promote awareness of the physical, emotional, and educational needs of children ages 0-5 as measured by the Early Development Instrument (EDI) in our community and to promote partnerships with community agencies to address the identified need. The agreement will go through June, 2023. The EDI is a validated, population-based measure of early childhood development in several key domains (physical health, emotional maturity, social competence, language skills, cognitive skills, communication skills, and general knowledge). During the 2021-22 school year, MVSD kindergarten teachers completed EDI surveys on each of their students and data from the EDI will help identify the district-specific and community-wide needs of children ages 0-5.
