## **Presentation on MVSD's Facilities Program Progress Provided for the Board**

A presentation on MVSD's Facilities Program progress was given by Darin De Knikker, Associate Superintendent of Business Services, providing a review of the District's bond priorities and the progress on bond projects. The presentation highlighted the priority projects which focused on central infrastructure, building infrastructure, and health/safety areas. Underground utility projects have been completed at all the K-6 and K-8 sites, with Cogswell and Voorhis scheduled for this upcoming year. Painting and fence replacement will continue, and fire alarms replacement is nearly completed. Roofing projects will continue, and rooftop HVAC units are scheduled to be replaced as an ongoing project. Solar structures are also planned for installation beginning in the summer of 2023.

The District filed these projects as part of the state funding application process for state grant opportunities and the State Facilities Application was accepted. The State Funding for the modernization of MVSD will be 18 million dollars. These funds are scheduled to be released sometime this spring. The district will be using these funds for the modernization of district properties.
