# Board of Education Approves AB 181/185 Block Grant: Arts, Music, and Instructional Materials Discretionary Block Grant

Rabia Minhas, Director of STEAM & GATE provided the Board with an overview of AB 181/185 Block Grant: Arts, Music, and Instructional Materials Discretionary Block Grant. Through MVSD's arts partnership with the Los Angeles County Office of Education, the District will receive a grant of \$3.2 million through the 2025-26 school year for arts, music and instructional materials. Project partners for the grant include Disney, with 5th and 8th grade students having access to Disney powered learning through the Disney Imagination Campus, and Spotify with 5th and 8th grade students learning creative sound making in the classroom with the Soundtrap by Spotify program, including music making and podcasting.
