

2021-2022 Audit Report Presented to the Board

Priscila Flores, Accountant from Clifton Larson Allen(CLA) provided a summary of the District's 2021-2022 audit report indicating that MVSD continued its tradition of fiscal accountability and received its 24th consecutive outstanding audit opinion on the yearly state mandated financial audit. MVSD received an "unmodified" audit opinion, the highest opinion that can be rendered by an accountant. Commendations were given to Darin De Knikker, Associate Superintendent of Business Services and Strategic Planning, Desiree Reyes, Senior Director of Fiscal Service, and the entire Fiscal Service Team for their hard work and dedication.

Board Approves Resolution in Support of Reducing Gun Violence and Making Communities Safer

The Board of Education adopted a resolution supporting the United States Presidential Executive Order calling for Congress to take additional legislative action, including banning assault weapons and high-capacity magazines, requiring background checks for all gun sales, requiring safe storage of firearms, and expanding community violence intervention and prevention strategies and stand with victims of gun violence in demanding effective and comprehensive action from the federal government to protect school children.
