Board Honors Students Run Los Angeles (SRLA) Teams

The Board recognized the SRLA (Students Run LA) teams in attendance from Parkview and Twin Lakes Schools, as well as the team from Monte Vista, for their extraordinary feat of training for and completing the 2023 Los Angeles Marathon. Forty-five students from the three schools conquered the 26.2 miles, showing great endurance, athleticism, mental toughness and determination. The teams trained for 6 ½ months, logging over 500 miles in preparation for the March 19 event. The Board members commended the students for their extraordinary achievement, and thanked the coaches, Marcos Garcia from Parkview, David Dorf from Twin Lakes and Jorge Jimenez from Monte Vista, as well as all the volunteers for their excellent support of the teams.
