

2023-24 Draft LCAP was Presented to the Board

Dr. Lagozzino, Assistant Superintendent of Educational Services presented an overview of the 2023-24 Draft LCAP which detailed enhancements to the final year of the three year plan based on the feedback of our educational partners. Focusing on Goal 1 - Academic Success for All Students, the draft plan includes expanding Intervention Teachers in grades 3-6, afterschool STEM, and expanded instrumental music. Goal 2 - English Learner, Foster Youth, and Special Education/English Learner Student Success, the plan includes an ELPAC rev-up and the addition of a Newcomer Instructional Assistant. Enhancements for Goal 3 - Supports for Learning include increased campus supervision and an increase in PBIS implementation and funding. Goal 4 - Family Engagement and Community Partnerships updates include the coordination of family field trips and the creation of the Chaperone Academy.
